I will be 46 years old in October; I've only had one ticket in my life and that was when I was 20 growing up in Los Angeles. I've been a professional 100 ton in-dump truck driver for off highway huge earth movers for the mines for I don't know how many years. I pride myself on driving. I'm on SSDI; I just had shoulder surgery ten weeks ago and I couldn't afford to pay a ticket if my life depended on it, nor should I have received one. I would like my chance to tell you why I think this is ridiculous. After I told the officer my reason, he asked me if I knew why he had stopped me, and I said, "Well ya, I was accelerating to pass somebody." I was doing 5 mph over the speed limit when it happened; I was going 35 as I passed a woman in the left lane going down Capitol Blvd. 200 yards in front of the Library entrance. I had a guy 4' behind me tailgating me, who had been for at least 200 yards, and changed lanes with me into the middle when I tried to get him to quit tailgating me, and switched lanes from the right to the middle, and he continued to follow me. I told the officer this and he said, "Well, we're on an aggressive driving patrol today and the Feds are paying our salary today, not the City of Boise, so I am under obligation and **have** to write up everybody that I stop." I thought the Feds are paying your salary today, huh? Why am I going to a Boise court for this instead of Federal Court then if it's a Federal ticket? This is ridiculous; I really
